

BFE AND SFE PROGRAMS

Choose Proponent for your BFE and SFE Programs

BFE (Buyer-Furnished Equipment)

BFE is optional equipment chosen during the production of the aircraft and is commercially managed between the airline and the BFE suppliers. Aircraft manufacturers offer customers a choice of BFE equipment from a catalogue of listed qualified suppliers.

SFE (Seller- Furnished Equipment)

SFE is standard equipment and is generally sole-sourced to suppliers and is included in the airframe price. Generally, there are limited SFE options for the airline, but it allows the airline to standardize equipment where possible across fleet.
